Minutes of March 11, 2017

The March 2017 Stated Meeting was held in the Temple of Geneva Lodge #44 – 335 Lake Shore Dr. Lake Geneva, WI 53147-2044 on March 11, 2017.

WM Schmidt called the meeting to order at 10:10 AM and posted the Tyler. The lodge was opened for the regular dispatch of business in the Master Mason degree. WM Schmidt led the brethren in the Pledge of Allegiance.

WM Schmidt extended a hearty welcome and thank you to WM Keith of Geneva 44, and requested that each stand and introduce themselves along with their lodge affiliations. He then explained the purpose and process of Silas Shepherd Lodge as a lodge of research. WM Schmidt further explained that all members had received a copy of the minutes of the stated meeting of December 3, 2016 within the First Quarter Trestleboard. WM Schmidt accepted the minutes as distributed. He then asked if there were petitions and there were two upon the secretary's desk, Michael E. Snow of Independence 80 and Barry A. Axelrood of Jams M. Hays 331. Having secured their presence in good standing with the Grand Lodge of

Wisconsin WM Schmidt requested a vote from the brethren. The vote was found in the affirmative.

Mary Kay Christie wife of SW Christie is recovering from surgery.

Reports

WM Schmidt reported that arrangements are being made with Kettle Moraine High School of the Kettle Moraine School District to fund two \$1,000 scholarships for 2017. The Wisconsin Masonic Foundation will provide a payment of \$1,000 through the matching scholarship program. The amount of \$650.00 is provided from the Wisconsin Masonic Foundation via the Carl Skoog fund. The lodge will provide the additional \$350.00 as provided in the budget and by membership donations.

WM Schmidt reported on the history of the Pharos publication and the plan to produce the sixth issue for release at the Annual Communication in June. The theme of which is "Symbolism." Members are also needed to assist with the review of papers available for publication. The publication will be sold at the Silas H. Shepherd table in the Vendor area and is also available through the Web Site.

Communications

Three communications were received from the Grand Lodge of Wisconsin one bringing attention to the 173rd Annual Convocation on June 2nd & 3rd. one concerned the expulsion of Perry Friesler from the Grand

Lodge and lastly a reminder for attendance to the District 12 Spring meeting on March 28th 7:00 PM.

He then called upon Secretary Kay for the Treasurer's Report, and Membership Reports.

The Treasurer's Report -Secretary Kay reported that Income in the period was \$2,009.00 and expenses were \$105.00 resulting in an increase of \$105.00. Expenses during the period included postage for Trestleboards, and dues notices. The closing balance in the checking account is \$3677.99 The current CD value is \$3,267.26 which includes the 2015 interest earned of \$73.45. The total of cash assets is \$ 6,945.25.

The Membership Report based on MORI as of March 10, 2017 has a current membership of 133 3 of which are in limbo. There are 27 PMP members, 62 have paid their 2017 dues, 41 owe for 2017, 15 owe for 2016 dues only, and 4 members owe dues for 2015. The Secretary sent out a communication to the members owing dues with the previous Trestleboard in March.

Old Business

The June meeting will be held in West Bend and is hosted by West Bend Lodge #138 - 301 N. University Drive West Bend, WI 53147. The September meeting will be hosted by Unity Lodge in Kenosha. The December meeting will be at the Oconomowoc/ Hartland Lodge #42 at 3 Pillars in Dousman.


