## Minutes of December 3rd, 2016

The December 2016 Stated Meeting was held in the Henry L. Palmer Lodge #301 in Wauwatosa, WI 53222 on December 3<sup>rd</sup>, 2016. Officers Present

WM Wackman called the meeting to order at 10:10 AM and posted the Tyler. The lodge was opened for the regular dispatch of business in the Master Mason degree. WM Wackman led the brethren in the Pledge of Allegiance.

WM Wackman extended a hearty welcome and requested that each stand and introduce themselves along with their lodge affiliations. He then explained the purpose and process of Silas Shepherd Lodge as a lodge of research. #### Reports

Secretary Kay reported that a Silas Shepherd presentation was made at Horicon-Neosho lodge on the 47<sup>th</sup> Problem of Euclid and was received very well.

#### Communications

A communication was received from the Grand Lodge of Wisconsin one bringing attention to the expulsion from the Grand Lodge of Richard W. Marx formerly of Frontier-Badger Lodge #45.

He then called upon Secretary Kay for the Treasurer's Report, and Membership Reports.

The Treasurer's Report - Secretary Kay reported that Income in the period was \$75.00 and expenses were \$904.92 resulting in a decrease of \$330.24. Expenses during the period included the printing and postage for Trestleboards, and dues notices and \$150 to WBro. John Wackman's AC travel, \$307.92 for PM Apron. The closing balance in the checking account is \$830.23. The current CD value is \$3,267.26 which includes the 2015 interest earned of \$73.45. The total of cash assets is \$4,097.49.

The Membership Report based on MORI as of December 3, 2016 has a current membership of 136 The Secretary sent out a communication to the members owing dues with the Trestleboard in December.

The emblems are \$5.00 and can be purchased at our meetings or by contacting our Brother Secretary:


