#### Reports

PM Kay reported on the history of the Pharos publication and the seventh issue for release was at the Annual Communication in June. The theme of which is "Application." Members are also needed to assist with the review of papers available for publication. The publication will be sold at the Silas H. Shepherd table in the Vendor area and is also available through the Web Site. Secretary Kay further explained the plan to offer a discount of the entire series to all the lodges in Wisconsin and that a mailing of such was made to all of the secretaries of the Wisconsin bodies.

#### Communications

WM Ryan then called upon Secretary Kay for the Treasurer's Report, and Membership Reports.

The Treasurer's Report - Secretary Kay reported that there had been no income and expenses for the period were \$250 for printing and

mailing of the trestleboard. The checkbook was at \$514. The current CD value is \$3,267.26 which includes the 2015 interest earned of \$73.45. The total of cash assets is \$3,781.26.

The Membership Report based on MORI as of September 8, 2018 has a current membership of 129. There are 27 PMP members, 24 owe for 2018, 14 owe for 2017 dues only, and 8 members owe dues for 2016. The Secretary sent out a communication to the members owing dues with the previous Trestleboard.

#### **Old Business**

Secretary Kay said we now have the capability to accept credit card payments through Square and a trial run was made by the WM of Wauwatosa lodge who purchased the discounted set of books for his lodge. The December meeting will be hosted by our home lodge of Lake Country Freemasons 4 \#42 and that they have relocated to a permanent home at 2919 N. Dousman Rd in Oconomowoc.

The new "ourlodge page" is up and running there will no longer be ab annual fee. We will also be able to collect our 2019 dues via on-line payments through the website. New website http://1843-wi.ourlodgepage.com

The emblems are \$5.00 and can be purchased at our meetings or by contacting our Brother Secretary:




